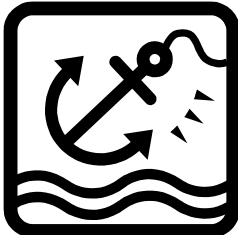

TOURNAMENT RULES

1. The Anchor-Lady Trio is a handicapped team/singles event and is open to 2023-24 USBC certified bowlers. Teams **MUST** be mixed and may consist of two males and one 600 club member or two 600 club members and one male. A **FEMALE** must bowl in the anchor position. This event will have two divisions based on combined averages of bowlers on team: **Div 1-Team Average: 564 & BELOW / Div 2-Team Average: 565 & UP**
2. Entry Fee: \$105 per team/\$35 per person.
3. Entry Fee breakdown: Lineage: \$9.00 Expense: \$2.50 Singles Prize: \$5.00 Team Prize: \$18.50.
4. One three-game series will be bowled by each entrant. This score will be used as singles and team score. Team maximum is 660. Handicap used will be 90% of the difference to 220 based on three games. Handicap is figured for each bowler, not by team units.
5. Averages: Bowlers must use their highest average based on a minimum of 21 games for the 2022-23 season. If no 2022-23 average, use 2021-22 season highest average. If no average for at least one of the last two seasons, use highest certified league average for 21 games or more as of December 10, 2023 (must furnish standing sheets from all leagues). All others use 220 (Scratch). Bowlers are responsible for verifying their own averages, whether submitted by the bowler, team captain or others. If the submitted average is lower than required and results in a lower classification or more handicap, the bowler's score is disqualified. If the submitted average is higher than required, prizes will be based on the submitted average.
6. USBC Rule 319a2 (Ten Pin Rule) **WILL APPLY**. USBC Rule 319d (Prior Prize Winnings) and USBC Rule 319e (Average Adjustment) **WILL NOT APPLY** to all USBC members.
7. Prize money returned 100%. Team Ratio at least one in five. Singles Ratio at least one in eight. All prize money will be distributed within 30 days after the conclusion of the tournament.
8. Any rules not covered shall be governed by USBC Tournament Rules. Decision of Tournament Committee shall be final unless an appeal is made in accordance with USBC Rule 329.
