- 1. All entrants must be current paid members of USBC, National 600 Club, and 600 Club of Southern Nevada.
- 2. USBC rules and regulations shall govern this tournament.
- 3. This is a Divisional Singles Tournament with 3 divisions based on entering averages.

  Diamond Division: 180 and above. Emerald Division: 179 through 160. Sapphire Division: 159 and below.
- 4. Bowlers must use their highest book average based on a minimum of 21 games in the following order: A) 2023-2024 winter/summer book. B) If no 2023-2024 winter/summer book, the 2022-2023 winter/summer book is used. C) If no book average for prior 2 seasons, the highest current average of at least 21 games as of the closing date will be used. Verification of 21 games must be sent with entry. All averages will be verified and changed if necessary.
- 5. Ladies wishing to bowl that DO NOT have an average will be placed in the Diamond Division.
- 6. Club Uniforms: All 600 Club members will wear the official club shirt. IF YOU ARE OUT OF UNIFORM, YOU WILL BE REQUIRED TO PAY AN OUT OF UNIFORM FEE OF \$5.00
- 7. Entry Fee: \$40.00 with pre-registration (\$10.50 lineage, \$3.00 expenses, \$26.50 prize fund). Pre-registered bowlers are requested to check-in 30 minutes prior to squad time. NO ENTRY FEE WILL BE RETURNED. If a check is returned, there will be a \$35.00 fee.
- 8. Prize Fund will be paid out 100% and payout will be at least 1 out of 4.
- 9. Walk-ins: Walk-ins will be accepted until 30 minutes before squad time, if openings are available and for additional late processing fee of \$4.00
- 10. THE 600 CLUB OF SOUTHERN NEVADA RESERVES THE RIGHT TO RERATE A BOWLER.
